Sub : Representation Regarding Overlooked Name Noting of Commercial Gr-C Staff (CCTS), Level-6.

Respected Sir,

With reference to the above-mentioned order, I would like to bring the following discrepancies to your kind attention :

1. Asha Amaliyar-CCTS/AKV

The name of Mrs. Asha Amaliyar-CCTS/AKV, was noted for transfer to BRCP-Booking/CYI Booking & BJW Booking on Dated : 04/01/2023 on spouse ground account.

However, her name noting was overlooked without any justified reason, despite her eligibility & the administrative need.

2. Pankaj Bhushan Kumar-CCTS/B/MHD

The name of Shri Pankaj Bhushan Kumar-CCTS/B/MHD, was noted for transfer to Nadiad Goods on Dated : 14/10/2023.

Despite clear vacancies, his name was not considered for the transfer.

3. Tejas Patel-CCRS/KBCS

Noted his name for ONGC on Dated : 26/07/21, but in-spite of vacancy same is not consider.

4. Jennifer R M-CCRS/RNO

The name of Mrs. Jennifer R. M.-CCRS/RNO, was noted for transfer to BRCP-Booking/CYI Booking & BJW Booking on Dated : 27/03/2023.

5. Sajidkhan-CCRS/MAPD

The name of Shri Sajidkhan-CCRS/MAPD was cancelled his name noting for BH/GOODS on Dated : 15/02/2024 although his transfer carried out from CCRS/MAPD to BH/GOODS.

However, her name noting was overlooked without any justified reason.

These oversights have caused dissatisfaction among staff members and undermine the transparency and fairness of the transfer and posting process.

In the interest of staff welfare and administrative efficiency, we request you to kindly review the matter, address these discrepancies, and issue necessary instructions to resolve the issues at the earliest.
