Sub : Request for Justice in Own Request Transfer of Shri Dharmendra Solanki-ESM-I/VDA to CYI.

Dear Sir,

WREU wishes to draw your kind attention to the unjust treatment meted out to Shri Dharmendra Solanki-ESM-I/VDA, working under SSE/SIG/ANND.

Shri Dharmendra Solanki had submitted his request for transfer to CYI under SSE/SIG/BRC-II jurisdiction more than two years ago. He was at Sr. No. 1 for transfer to CYI. Consequently, on Dated : 28/12/2023, his transfer order to CYI, vice Shri Chetankumar Makwana, was issued. However, due to Shri Chetan Kumar's refusal, the transfer could not be executed.

Once again, after a year, a fresh order was issued on Dated : 31/12/2024, transferring Shri Dharmendra Solanki to CYI in place of Shri Chetan Kumar Makwana. Shockingly, Shri Chetan Kumar again refused to move, leading to further delay. However, instead of honouring Shri Dharmendra Solanki's rightful claim, the administration issued a fresh order on Dated : 30/01/2025, in which Shri Chetankumar was finally transferred due to his second refusal. But instead of transferring Shri Dharmendra Solanki as per his rightful claim to CYI, the administration downgraded the post and posted Shri Sunil Bhai Solanki at CYI, ignoring Shri Dharmendra's name.

This is a clear case of injustice, arbitrary decision-making, and anti-staff welfare attitude on the part of the concerned Signal Department officers and the Personnel Branch. Such actions demoralize employees and undermine transparency in transfer policies.

Union Demands :

In the interest of staff welfare and fair treatment, WREU strongly demands that Shri Dharmendra Solanki be immediately posted at CYI as per his long-standing request and seniority. We urge the administration to rectify this error and uphold fairness in the transfer process.

Action taken may please be advice to union.
