**Sub :** Wrong fixation of seniority – Case of Shri Kaluram Meena,  
Tech-III working under Sr. DEE/TRS/BRCY.

Dear Sir,

The union wishes to draw your kind attention to the grievance regarding the wrong fixation of seniority in the case of Shri Kaluram Meena, Technician Grade-III, working under Sr. DEE/TRS/BRCY.

Shri Kaluram Meena had taken mutual transfer with Shri Mukesh Kumar. Similarly, Shri Samarth Lal Meena had taken mutual transfer with Shri Rajesh Kumar. Both employees belong to Electric Loco Shed and fall under the OBC category. Shri Kaluram Meena and Shri Samarth Lal Meena resumed duty in BRC Division on Dated : 01/08/2023.

As per Railway Board Circular No. 08/2019, the seniority of an employee after mutual transfer should be fixed based on the seniority position of the employee with whom the transfer was made. Accordingly:

Shri Kaluram Meena should get the seniority of Shri Mukesh Kumar, who was senior to Shri Rajesh Kumar.

Consequently, Shri Kaluram Meena should be placed senior to Shri Samarth Lal Meena in the seniority list.

However, it has come to notice that the seniority has been incorrectly fixed, which is causing injustice to Shri Kaluram Meena.

**The union therefore requests your good office to :**

1. Correct the seniority position of Shri Kaluram Meena as per the above guidelines.
2. Include his name in the forthcoming selection of Technician Grade-II, giving him his rightful chance and ensuring justice to a senior employee.
