Sub : Request to Protect and Give Justice to Medically Decategorised Staff Shri Mohan R. Chauhan, Jr. Clerk, C&W Depot, KRCA.

Dear Sir,

It is with deep concern that we bring to your kind notice the case of Shri Mohan R. Chauhan, Jr. Clerk, working at C&W Depot, KRCA, who has been facing undue harassment at his workplace.

Shri Mohan R. Chauhan was medically decategorised in the year 2020 and was suitably posted as Junior Clerk in C&W Depot, KRCA. Since then, he has been sincerely discharging his duties and has successfully handled table and office work up to the year 2023. Thereafter, he was directed to perform duties in the Store for the last two years. Though he does not possess computer proficiency or fluent English skills, he has been performing all clerical and store-related work to the best of his ability with dedication.

It is regretted to point out that despite his satisfactory performance, he is being harassed and put under mental pressure by Shri Manish Chandra Tiwari, SSE In-Charge, and Shri Peterus, COS, C&W Depot, KRCA. Presently, he is being tossed between SSE In-Charge, COS, and ADME/KRCA, creating an environment of undue stress. Shri Mohan R. Chauhan, vide his application dated 18.08.2025, has categorically stated that he is under huge mental pressure and if anything untoward happens to him, the above two officers may be held responsible.

In view of the above, union strongly urges your good office to kindly intervene in this matter, protect Shri Mohan R. Chauhan from further harassment, and ensure justice to him. Being a medically decategorised staff, he deserves sympathetic consideration and a stress-free working environment in line with Railway Board's guidelines.

Action taken may please be advice to union.
