(2) Shri Deepak Katariya and others has filed SCA No. 9388/2025 before Hon'ble High Court Ahmedabad challenging the orer passed on dated 08-05-2025 in OA No. 104/2024 regarding seniority of ALP/Sr. ALP. The matter is pending before Hon'ble High Court at present . Moreover Hon'ble Highe Court Ahmedabad has issued intrem order that" **Seniority of Private Respondents will be subject to further orders passed by this court."**

(3) A clarification has also been sought from HQ–CCG with reference to the contentions mentioned in the orders passed in OA No. 104/2024 and OA No. 105/2024 regarding the relevant codal provisions..
